Our mission statement is: Good Samaritan Ministries, motivated by Catholic social teaching, works in our community to advance family life, human dignity and the common good. We provide services to meet the physical, social, emotional and spiritual needs of individuals and families of all faiths, especially those most in need. Good Samaritan Ministries provides stability to Helena area community members by creating a network of care and connecting individuals and families to resources to help create stability in their lives. We have been serving Helena and its surrounding community members for over 30 years. Since our inception, we have contributed over \$25M to community members in need. Our partnerships with other area nonprofit agencies provide warm hand off services to medical facilities, employers, government agencies- including the police and EMT's, housing and benefits to meet the day-to-day and long-term needs of individuals in our community.

A significant remediation program component that GSM created to support (mainly unhoused) people in treatment and recovery of opioid addiction has been the continued growth of our peer-support programs, connection to care navigation and street outreach interventions. We help those in crisis by providing linkages to continuity of care, helping individuals navigate housing options, opioid treatment referrals, peer support stabilization groups, mental health referrals, linkage to employment, education and volunteer opportunities.

We are seeking program support funding to expand our current extensive prevention and recovery solution Outreach efforts including: 1. expanding our warm hand off programs and recovery access services, and (by funding a PTE pilot Resource & Housing Navigator for the (already funded) Assistance Coordinator 2. increasing our peer outreach and crisis intervention recovery approach by adding additional team member (FTE Peer outreach Supporter to enhance current - funded Outreach programs and .

NEW - FUND 1 FTE POSITION: We currently have one Outreach Specialist, and this individual has been instrumental in increasing engagement and trust with the unhoused and individuals seeking support in their

sobriety journey. However, the position could be more expansive. We seek funding to add one FTE employee for the STOPS Campaign - a professional Peer Recovery Specialist with Naloxine Administration training and navigation facilitation experience to work in tandem with the Outreach Specialist.

NEW - FUND 1 PTE POSITION. Fund another PTE to assist our GSM Assistance Coordinator with housing, benefits and other social service needs to address crisis intervention and prevention activities will enhance our ability to serve this needful population. To remain sober without housing, stability and support is often unmanageable. The current (funded) Assistance Coordinator does not specifically work with individuals in opioid crisis. Additional personnel will collaborate between the Outreach and Assistance programs to ensure access to wrap around services and supports.

Grant funding is intended for the creation or expansion of opioid prevention, treatment, and recovery projects. The money is **NOT** meant to replace or supplant existing funding.

Most of the funding will be used for augmenting staff support for an existing program we seek to expand. Funds will be used for staff support, purchase of equipment, and providing program materials and training to implement and evaluate the proposed STOPS Campaign! We currently have the following funding:

Our Place Drop In Center, a Peer Support Behavioral Health facility is funded by Lewis & Clark County in conjunction with Behavioral Health & Developmental Disabilities @ \$125,000 annually and community donations and covers our Operations costs - including program salaries, facility rental and insurance, utilities, program supplies and GSM Administration Contract Management. These are not outreach positions per se although our Street Outreach employee is central to aligning individuals from the unhoused community with supports within the Drop in Center.

The GSM Assistance Coordinator role is funded at \$52,006.05 through our Assistance Ministry social entrepreneurial model - our store. We are seeking funds to augment this program and provide additional "BRIDGE" support personnel (1 PTE) to this program to specifically address the unsheltered with Opioid addiction issues - hospitalization, incarceration, domestic violence, sexual abuse, criminality and victimization.

The current FTE Street Outreach employee is funded at \$47,462.61 by ESG through the Rocky Mountain Development Council to provide outreach services to unsheltered individuals, including warm handoff to housing navigation, medical, mental health and substance abuse (generic) services. This has been a standalone program with one FTE. We are seeking funds to augment this program and provide additional "field" support personnel (1 FTE) to this program to specifically address the unsheltered with Opioid addiction issues - hospitalization, incarceration, domestic violence, sexual abuse, criminality and victimization.

We are aware of other programs that utilize the peer Support methodology. However, to our knowledge, we are the only program service individuals within an unsheltered domain and will bring these folks to the hospitals, rehabs, counseling, medical, and other supportive services they need to seek and find recovery and stabilization. We understand this is a one year determined grant with the potential for another year extension and will seek additional funding for continuation through other grant sources, fundraising, donor development and our events.

Our outreach program is designed to engage people who are at-risk for drug overdose. Services are offered in non-traditional settings such as campsites, public parks, libraries, bus or train stations, exit or entrance ramps to roads and highways, abandoned buildings, or under bridges. Our current outreach worker engages people

at local basic needs organizations such as community meal sites, soup kitch ens, or clothing centers. Outreach services consistently benefit individuals who do not have access to transportation and our Outreach program serves as the front door to connect unsheltered or unstably housed individuals to homeless and permanent housing services, treatment programs and harm-reduction resources. Good Samaritan Ministries current outreach program connected over 250 ignored or underserved people in our region with emergency services, referrals, longer-term mental and physical health services, addiction and treatment resources, social service referrals and infectious disease screening in 2023. Our current Outreach services have helped to reintegrate unsheltered individuals and families into the larger community. All Good Samaritan Ministries programs - including the Our Place Drop-In Center, Assistance Ministry and current Outreach programs, meet people where they are, both geographically and emotionally.

Our effectiveness has always been in our responsive approach to our clients and the community. We WANT to see a re-integration and healing for people who perceive the unhoused and addicted as a blight on their community, with a new perception of this population by raising awareness of the causes of the disease of addiction within our communities, the direct link - cause and effect if you will, of the perceptions that continue to stigmatize the unsheltered and addicted neighbor. A main component of our outreach work is to provide basic needs, harm? reduction tools, and peer recovery support to vulnerable populations that often have little or no access to services and have become isolated or alienated from the greater community. We are their bridge and in our outreach capacity, are also well positioned to act as advocates for the people we serve and educators to those who seek to understand the crisis among them. This includes advocating for systemic policy change. Our effectiveness has been tried and tested in over 35 years of increased community outreach endeavors, where thousands of lives have been transformed through access to services.

Program Abstract

Program Description*

Based on data from the statewide strategic planning efforts to combat the opioid epidemic in Montana, the following sub-populations have also been identified for targeted activities: individuals re-entering the community from correctional settings; individuals in rural and isolated areas - including encampments in the Canyon Creek and East Valley areas; individuals experiencing homelessness; tribal populations; veterans, military service members and military families; pregnant women and parents with OUD; individuals with physical disabilities and individuals who have experienced trauma, toxic stress or adverse childhood experiences (ACEs). Good Samaritan Ministries STOPS Campaign is an expansion of an already busy outreach program where we connect people who need help through well-coordinated deep community partnerships. The overarching goal of the project is to increase access to OUD treatment, coordinated and integrated care, recovery support services and prevention activities to reduce the prevalence of OUDs, stimulant use disorders, and opioid-related overdose deaths. The project approach includes implementing activities from the Core abatement Strategies by developing and supporting state, regional, and local level collaborations and service enhancements. Our current Outreach Services staff member recently identified 24 out of roughly 100 people in rural areas (outside of the Capital area) who identified as actively involved in their addiction, seeking recovery solutions or in early recovery. Other rural designated areas of the County that have yet to be consistently approached include Lincoln, Marysville and Birdseye - all of which host (unhoused people) encampments according to the most recent Point in Time Survey.

Prevention Goal 1: Increase prevention activities to reduce OUDs, stimulant use disorder, and opioid related deaths:

Objective: Provide peer-support, recovery, community navigators and connections to community-based services and linkages to other community supports - referrals through our collaborative non-profit and community partners in the mental health, substance abuse agencies; assistance navigating social services eligibility, housing coordination and treatment assistance.

Prevention Goal 2 Address the needs of criminal justice-involved persons and people in treatment and recovery and improve access to short-term and long-term recovery support services.

Objective: Expand our Outreach Team to include a FTE Peer Specialist to augment current outreach efforts and provide additional support to individuals in recovery and ensure continuity within our expanded warm hand-off services.

Strategy: Fund an FTE trained Peer Support Specialist, in field (encampments, jails, street outreach, community and Our Place program site. Expand our ability to facilitate in-jail groups, programs, peer-recovery activities and outreach with the added 1 PTE Navigator on our STOPS team.

Sustainability: The majority of the STOPS Campaign activities proposed are projects that will inherently live past the life of the grant. We anticipate serving this community beyond the initial one-year grant-funded term. Initially, if successful with this grant application, the expansion will be a pilot to ensure the current level of need is met immediately. During this time, we will fundraise and seek additional instruments to ensure the continuity of the program. GSM has a long history of initiating a program (under similar terms) and moving the pilot program to a long-term and sustainable program within the portfolio of assistance the agency seeks to provide in the community. The Opioid grants are devised to augment current funding while GSM expands our Street Outreach and support model, sustain targeted media activities and critical treatment and recovery access points through the grant period, and become self-sustaining through Peer Support recovery funds, raised fundraising efforts and additional potential grant dollars towards this grant end. In addition, GSM will continue to actively pursue additional grant funding to grow and expand activities to combat the opioid epidemic across prevention, billable treatment and recovery activities with our collaborative partnerships seeking peer support programs, with a calculated eye on pursuing those activities that transverse all systemic and ongoing causes and those that address common root causes and ever-evolving trends of substance use in Montana and our local communities



This responds to your June 2, 2017, request for information regarding the status of your group tax exemption.

Our records indicate that you were issued a determination letter in March 1946, that you are currently exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, and are not a private foundation within the meaning of section 509(a) of the Code because you are described in sections 509(a)(1) and 170(b)(1)(A)(i).

With your request, you provided a copy of the Official Catholic Directory for 2017, which includes the names and addresses of the agencies and instrumentalities and the educational, charitable, and religious institutions operated by the Roman Catholic Church in the United States, its territories, and possessions that are subordinate organizations under your group tax exemption. Your request indicated that each subordinate organization is a non-profit organization, that no part of the net earnings thereof inures to the benefit of any individual, and that no substantial part of their activities is for promotion of legislation. You have further represented that none of your subordinate organizations is a private foundation under section 509(a), although all subordinates do not all share the same sub-classification under section 509(a). Based on your representations, the subordinate organizations in the Official Catholic Directory for 2017 are recognized as exempt under section 501(c)(3) of the Code under GEN 0928.

Donors may deduct contributions to you and your subordinate organizations as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to them or for their use are deductible for federal estate and gifts tax purposes if they meet the applicable provisions of section 2055, 2106, and 2522 of the Code.

Subordinate organizations under a group exemption do not receive individual exemption letters. Most subordinate organizations are not separately listed in Publication 78 or the EO Business Master File. Donors may verify that a subordinate organization is included
