Naloxone Awareness, Education, and Prevention:

Broad distribution of opioid overdose reversal medications to individuals with OUD, their families, friends, community events, and local schools.

Opioid-related Treatment:

Outpatient MOUD treatment for about 100 individuals monthly at various locations, including clinics, detention centers, prerelease centers, and through a mobile van.

New patients undergo DSM OUD screening and additional mental health and substance use disorder assessments. Treatment plans are discussed post-assessment, with options for Hepatitis C, Syphilis, and HIV treatment.

Care for Pregnant & Postpartum Women and Criminal Justice-Involved Persons:

Collaboration with obstetrical providers to offer MOUD to pregnant individuals.

Support for prerelease clients by continuing MOUD and initiating treatment for those with a history of OUD, addressing the high risk of fatal overdoses post-incarceration.

Warm Hand-off Programs and Connections to Care:

Comprehensive wrap-around services including housing, transportation, job placement, and childcare resources.

Access to free legal services through Montana Legal Services.

Integrated MOUD care during regular primary care visits and same-day or next-day visits for hospital-initiated MOUD patients

Leadership and Training:

Collaboration with the Montana Addiction Medicine Network and the Montana Primary Care Association on harm reduction strategies, training, state priorities, and tracking opioid indicators.

Presentations on reducing barriers to care and improving continuity of care.

Up-to-date training for staff on best prescribing practices.

SWMTCHC is committed to ensuring the long-term sustainability of our MOUD program, extending well beyond the funding period. We strive to make a lasting positive impact on individuals affected by opioid use disorder, championing a healthier future for Butte-Silver Bow.

Grant funding is intended for the creation or expansion of opioid prevention, treatment, and recovery projects. The money is **NOT** meant to replace or supplant existing funding.

Yes, our MOUD program is the current recipient of the SOR grant totaling \$100,000 per year. The current grant funding of \$100,000 is designated to support 0.33 Full-Time Equivalent (FTE) of a nurse practitioner, along with 0.25 FTE for both a registered nurse (RN) and a medical assistant (MA), as well as a care manager. The addition of these requested funds would complement these existing resources, enabling us to expand our MOUD program. This expansion would allow us to increase the FTEs of our committed staff, thereby enhancing our capacity to serve more patients. Specifically, we aim to extend our MOUD services to patients that have entered the justice system, dedicating more time and resources to individuals that have been incarcerated. This focus will support a healthier transition back into the community, ultimately fostering better long-term outcomes for these individuals. Collaborations with local organizations and agencies will be strengthened, facilitating a comprehensive network of support for those in need. Overall, our goal is to create a sustainable and impactful program that not only addresses the immediate needs of our patients but also contributes to a healthier, more supportive community environment.

Southwest Montana Community Health Center (SWMTCHC) started our Medications for Opioid Use Disorder (MOUD) program in 2018. Since then, we have provided hundreds of monthly MOUD visits at all three of our clinics in Butte, Anaconda, and Dillon. We offer a multi-disciplinary team with medical providers, behavioral health, dental, care managers, and clinical pharmacists. To lower barriers to care, we offer a walk-in program, where anyone can come into the clinic and start MOUD that day if appropriate.

Our primary purpose is to provide comprehensive, evidence-based treatment options to individuals facing opioid use disorder (OUD), thereby enhancing their quality of life and reducing the incidence of opioid-related harm and fatalities. We prioritize accessibility, ensuring that effective medications are available to all individuals with OUD, regardless of their socioeconomic background or geographic location. We emphasize a patient-centered approach, customizing treatment plans to address each patient's unique needs while ensuring that care is respectful, non-judgmental, and supportive.

In addition to improving MOUD accessibility, SWMTCHC promotes awareness about Narcan, a critical tool in reversing opioid overdoses. We engage with the community by collaborating with local organizations, stakeholders, and policymakers to cultivate a supportive environment for individuals in recovery and advocate for policies that improve access to MOUD. By sharing resources and expertise, we aim to build a robust framework that addresses the multifaceted challenges faced by individuals with OUD.

We are dedicated to fostering long-term recovery and resilience, empowering individuals to rebuild their lives with confidence and hope. Our team also works tirelessly to stay updated with the latest advancements in treatment and recovery strategies, ensuring that we offer cutting-edge care and support. To address the pressing issue of opioid use disorder (OUD) and its devastating impact on our communities, we are committed to implementing a comprehensive strategy that focuses on increasing accessibility to Medication for Opioid Use Disorder (MOUD), expanding Narcan distribution, and providing essential community education. Our first goal is to enhance the accessibility of MOUD, particularly for vulnerable populations such as pregnant individuals, those involved in the justice system, individuals who have recently experienced overdoses, and those who are unhoused. By ensuring that these groups have easier access to lifesaving treatments, we aim to reduce the barriers that prevent them from receiving the care they need. This funding opportunity would enable our MOUD Nurse Practitioner to dedicate more time specifically to MOUD patients. Our distribution efforts will target individuals with OUD, their family members and friends, key local organizations and businesses, and the broader community. By making Narcan more readily available, we can empower more people to act swiftly in emergency situations, ultimately saving lives and reducing the number of fatal overdoses.

Furthermore, we recognize the importance of community education in our efforts to combat the opioid crisis. We will provide comprehensive education on harm reduction strategies, aiming to reduce the stigma associated with substance use and promote a more compassionate and informed approach to addressing this issue. Our educational initiatives will also focus on discouraging the initiation of substance use, particularly among young people, by raising awareness about the risks and consequences associated with opioid use.

To ensure the effectiveness of our initiatives and to continuously improve our approach, we will implement a robust tracking system that meticulously monitors various aspects of our program. First, we will track the overall number of patients receiving Medication for Opioid Use Disorder (MOUD), with detailed subcategories for those who are pregnant, justice-involved, have recently experienced overdoses requiring medical care at the Emergency Department, and those who are unhoused, particularly those seen via our mobile van. This detailed tracking will allow us to identify trends, gaps, and areas needing additional support, ensuring that our services are reaching the most vulnerable populations effectively.

In addition to monitoring MOUD patients, we will also track the distribution of Narcan on a monthly basis. This includes recording the amount of Narcan given out and categorizing the recipients into those with an OUD, their family members and friends, key local organizations and businesses, and community members. By analyzing this data, we can assess the reach and impact of our Narcan distribution efforts, ensuring that this life-saving medication is accessible to those who need it most and can act swiftly in overdose situations.

Furthermore, we will keep a detailed record of the number of presentations we conduct and the number of attendees at each session. These presentations are crucial for community education on harm reduction,

stigma reduction, and discouraging substance use initiation. By tracking attendance and engagement, we can evaluate the effectiveness of our educational initiatives and make necessary adjustments to maximize their impact.

Through these comprehensive tracking methods, we aim to create a data-driven approach that not only measures our progress but also informs our future strategies. This will enable us to adapt and refine our efforts, ensuring that we are making a meaningful difference in the lives of those affected by opioid use disorder and contributing to the overall health and safety of our community.

To ensure the precision and effectiveness of our initiatives, we will implement a comprehensive data tracking system that integrates both electronic and manual methods. Utilizing our electronic medical records system, Epic, we will meticulously track the number and type of patients receiving Medication for Opioid Use Disorder (MOUD) on a monthly basis. This system will allow us to categorize patients based on specific criteria such as pregnancy, justice involvement, recent overdoses requiring emergency medical care, and those who are unhoused, particularly those seen via our mobile van. By systematically recording this data, we can gain valuable insights into the demographics and needs of our patient population, enabling us to tailor our services more effectively and ensure that we are reaching the most vulnerable groups.

In addition to tracking MOUD patients, we will monitor the distribution of Narcan using a combination of paper and electronic methods. Physical Narcan distribution will be recorded on a paper sign-out sheet, while electronic prescriptions will be tracked through our electronic medical records. Each month, we will tally the total amount of Narcan distributed and categorize the recipients into those with an OUD, their family members and friends, key local organizations and businesses, and community members. This dual approach ensures comprehensive and accurate tracking of Narcan distribution, allowing us to assess the reach and impact of our efforts and ensure that this life-saving medication is accessible to those who need it most.

Furthermore, we will use attendance sheets to record the number of attendees at each community presentation. These presentations are a crucial component of our educational initiatives, focusing on harm reduction, stigma reduction, and discouraging substance use initiation. By keeping detailed records of attendance, we can evaluate the effectiveness of our outreach and make data-driven adjustments to enhance our educational programs.

Our Medications for Opioid Use Disorder (MOUD) team is a dedicated group of professionals committed to combating the opioid crisis and supporting individuals on their journey to recovery. At the heart of our team are compassionate healthcare providers, including nurse practitioners, registered nurses, behavioral health therapists, and care managers, who bring a wealth of experience and expertise in addiction medicine. They work diligently to ensure that each patient receives personalized, evidence-based care tailored to their unique needs.

Leading our team is Kara Howard, FNP. Kara is not just a nurse practitioner; she is the heart and soul behind our MOUD program, which she initiated in 2018. Her unwavering dedication continues to drive the program forward, making a profound impact on our clinic and community. Historically, Kara's primary role is a Family Nurse Practitioner managing a complete panel of primary care patients. This funding would enable SWMTCHC to support Kara's passion by allowing her to dedicate more time to MOUD patients. Her expanded role will allow for closer collaboration with care teams, sharing her insights and experiences to further refine our approach to treatment. Her dedication to this cause not only serves the patient but also inspires the entire team to strive for excellence in delivering comprehensive healthcare solutions.

Within our clinic, Kara's compassionate care shines through as she meets with MOUD patients both inperson and via televisits. She meticulously develops our protocols and passionately educates our staff, ensuring everyone from the front desk to providers is well-versed in MOUD. Her training emphasizes reducing stigma, promoting harm reduction, and adhering to evidence-based prescribing practices.

Kara's commitment extends beyond our clinic walls. She conducts educational presentations on Narcan and spearheads community distribution efforts. Her outreach includes impactful presentations to all students at Butte High School, where she addresses the dangers of substance use and the risks of counterfeit pills.

Over the years, Kara has forged strong, collaborative relationships with various community partners. Our partnership with the local hospital, for instance, ensures that patients started on MOUD at the hospital receive same-day or next-day visits at our clinic, providing seamless continuity of care. This hospital- Community Health Center bridge program has garnered praise at the state level and among CHCs in the northwest region. Kara also collaborates closely with local obstetrical providers to offer MOUD to pregnant individuals, ensuring they receive the care they need. Her multi-year collaboration with the criminal justice system and city government has led to our jail and prerelease center now allowing MOUD, prescribed by our SWMTCHC providers. Starting OUD treatment while sober helps prevent further incidents of substance use, supporting individuals in achieving their long-term goals. This initiative-taking approach fosters stability and healthier transitions back into the community. Through her diligent efforts at our clinic and in the community, Kara has significantly improved access to MOUD, enabling individuals to receive evidence- based care whenever they are ready. Her work is a testament to her compassion, dedication, and unwavering commitment to making a difference in the lives of those she serves.

Another vital member of our MOUD team is our devoted care manager, Beth Hettick. Beth serves as a guiding light and source of support for our patients. Her responsibilities extend well beyond mere care

management; she cultivates meaningful, trusting relationships with everyone, consistently meeting with them and remaining a steadfast, dependable presence in their lives.

For those without insurance, Beth navigates the complexities of enrolling them in Medicaid or ACA, and for the underinsured, she facilitates access to the 340B sliding scale for appointments and medications. Her dedication extends to pregnant individuals, including those with OUD, ensuring they receive the comprehensive care they need during such a critical time. Beth also collaborates closely with St. James to maintain continuity of care, ensuring that patients receive consistent and coordinated support. Through her intensive care management, Beth embodies our holistic approach to supporting long-term recovery, addressing not just the medical but also the social and emotional needs of our patients.

Together, our MOUD team is united by a shared mission; to provide comprehensive, integrated care that improves the lives of individuals with opioid use disorder. Through their combined expertise, compassion and dedication, they strive to make a lasting impact on the communities they serve, offering hope and healing to those affected by the opioid crisis.

Funding plays a vital role in the MOUD program, as it directly influences our capacity to deliver life-saving treatment and support. Sufficient funding guarantees that we can maintain and improve access to essential medications, providing access for all patients, regardless of their ability to pay.
