This letter acknowledges receipt of your request for non-profit tax-exempt status for your organization. Upon review of the information submitted by you, we have classified SANDERS COUNTY as a non-profit tax-exempt entity under Montana Code Annotated, §15-31-102(1).

An organization classified as non-profit tax-exempt is only required to file a Montana Corporation License Tax Return when it has any unrelated business taxable income, as defined by section 512 of the Internal Revenue Code of 1954 (26 W.S.C. 512), as amended, resulting in a federal unrelated business income tax liability of more than \$100. In that case you would be required to file Form CLT-4, which is available online at www.mt.gov/revenue or by calling (406) 444-6900.

Dear MOAT Region 5 board members,

I would like to offer clarification of which Exhibit E remediation uses the purchase of a body scanner can be justified with and I apologize for the inconvenience.

In general, Schedule A Core Strategies, Section F “Treatment for Incarcerated Population”, line 2. “Increase funding for jails to provide treatment to inmates with OUD” is the specific strategy that a body scanner falls into.

Furthermore, Schedule B Approved Uses – Part One: Treatment – Section D. Address the needs of criminal justice-involved persons – Line 4. Provide evidence-informed treatment, including MAT, recovery support, harm reduction, or other appropriate services to individual with OUD and any co-occurring SUD/MH condition who are incarcerated in jail or prison; is a specific use to be referenced.

Lastly, Schedule B Approved Uses – Part Two: Prevention – Section H. Prevent overdose deaths and other harms (harm reduction), more broadly supports the concept of stopping illicit drugs from entering the jail.

Body scanners are used to detect contraband, including drugs, being smuggled into jails, potentially preventing overdose deaths and other harms within the incarcerated population. This aligns with the "Prevent Overdose Deaths and Other Harms (Harm Reduction)" category in Exhibit E, which aims to reduce opioid-related harms as noted above. Body scanners can complement traditional search methods, such as pat-downs, which may not always detect concealed drugs or items hidden within body cavities.

By detecting contraband, body scanners improve the overall safety and security of jails, benefiting both staff and inmates, also allowing individuals to focus on treatment and recovery.

Finally, below are 4 examples in which a body scanner has already been approved for purchase under Exhibit E of the National Opioid Settlement funding.

The use of opioid settlement funds for jail-based body scanners has been **approved in multiple jurisdictions** under Exhibit E, including:

- **Trumbull County, Ohio** (July 2025) – \$92,000 scanner upgrade approved.
- **Kalamazoo County, Michigan** – Scanner installed after multiple in-custody overdoses.
- **State of West Virginia** – Statewide approval for jail/prison scanners using settlement funds.

- **St. Clair County, MI** – Used settlement funds for purchase of body scanner inside jail.

I understand the hesitation to approve this grant as it has been a controversial topic. But overall, purchasing a body scanner will supplement the efforts we are already making with local funds such as broadening our AA/NA classes and training for our law enforcement to better manage OUD in all environments. Thank you for your time and consideration.
